I. DECLARATION OF NON-RECEIPT OF ASSISTANCE IN MORE THAN ONE STUDY PROGRAM

In connection with Article 93 sec. 1 of the Act of 20 July 2018 on Higher Education and Science and § 8 sec. 5 of the Regulations for Student Benefits at KBU, I declare that in the academic year covered by this application, I will receive assistance (social scholarship/disabled persons' scholarship/Rector's scholarship/allowance) only at KBU for the field of study.

II. DECLARATION OF NOT COMPLETING OTHER STUDIES

In connection with art. 93 sec. 2 of the Act of 20 July 2018 on Higher Education and Science and § 8 sec. 7 and 8 of the Regulations for Student Benefits at KBU, I declare:

As a student of the first-cycle program - that I have not completed any studies to date and I am aware that completing other studies would deprive me of the right to assistance for my current studies.

As a student of the second-cycle or uniform master's study – that I have not completed any studies with a master's degree or equivalent to date, and I am aware that completing such studies would deprive me of the right to assistance for my current studies..

III. DECLARATION OF STUDY PERIOD

Pursuant to the art. 93 sec. 2 of the Act of 20 July 2018 on Higher Education and Science and with § 8 sec. 9 Regulations of benefits for students of KBU I declare that the total duration of all my studies to date (completed and incomplete) has not exceeded 12 semesters, regardless of their type, with the exception that during this period, benefits are available for:

- 1) First-cycle studies – no longer than 9 semesters;
- 2) Second-cycle studies – no longer than 7 semesters;
- 3) Uniform master's studies, which have a duration of 11 or 12 semesters according to legal regulations – the total period specified in sec. 9 pts. 1-2, is extended by 2 semesters;
- 4) In cases where a disability arose during studies or after obtaining a professional title, a scholarship for disabled persons is granted for an additional period of 12 semesters.

I commit to immediately notify the Financial and Accounting Department at KBU if, in the academic year covered by the application, during the receipt of assistance at KBU, the above declarations become outdated due to receiving assistance at another university or completing other studies.
